<u>IMPORTANT BOARD STATUS UPDATE</u>: We have had recent changes in the township leadership. CLT clerk Sue Sullivan departed not quite mid-way through her 4-year term, citing among other things her health and housing problems. We sincerely thank her for her many years of public service and wish her well in her well-earned retirement. Besides missing her personally, this meant that as of Oct. 1st we had no appointed clerk to replace her. The remaining four seated board members were unable to come to a consensus on a replacement, even after several special meetings and two willing candidates. After repeated tie votes, the board averted higher authorities stepping in to assure the security of the mid-term elections (a large part of the clerk's work) by hiring the fully qualified former Deputy Clerk Halliday as a stop-gap measure, to perform all elections-related tasks. Finally, in a special meeting on October 25, the board considered a third candidate and unanimously voted to appoint Judy VanMeter as the new clerk with a start date of November 12, 2022. Ms. VanMeter is a longtime township resident and a well-seasoned 31-year veteran of helping to run the township elections. She is currently appointed as Precinct Board Chair. We sincerely thank the other candidates for applying, the community for participating in the process, and offer our congratulations to Judy in her new township position.

<u>CLEAN UP DAYS:</u> Plan ahead with these two summer 2023 Saturday dates for getting your oversized or awkward junk items to the dump: May 6th and August 5th. The location is still planned for the Frankfort Dow Airport parking lot on Airport Road. Look for new instructions on our website as the dates draw nearer.

<u>CRYSTAL LAKE AND INVASIVE SPECIES:</u> Did you know that the State and all townships around Crystal Lake have ordinances requiring boat cleaning that apply to all? CLT contributes money to the Benzie Conservation District whose mission is to prevent new aquatic invasive species from being introduced into local water bodies. To protect our precious waters, every floating craft operator should ensure that vessels of any type are clean of hitchhiking invasives, whether you are paddling a board or kayak, whether in a fishing trawler or driving a high speed motor boat. The Crystal Lake Watershed Association provides a free boat washing station at the DNR launch located 6 miles east of Frankfort (2 miles west of Benzonia/US-31) on M-115 at Mollineaux Road. ZONING: It has come to our attention that persons anticipating building small structures such as storage sheds, well houses, etc. are assuming that no permits are required for these structures because the State Construction Code does not require a Building Permit for structures less than 200 square feet. (BTW: This standard was recently increased from the previous 100 square feet.) However, the change in Building Permit requirements has no relationship to Township Zoning Ordinance requirements. **ALL STRUCTURES OF WHATEVER SIZE require a Land Use Permit from the Township Zoning Administrator**. The Land Use Permit is necessary to determine and assure that the placement of any structure meets all zoning requirements, particularly setback requirements. Doing **anything** to alter your property? Check with our Zoning Dept. first.

CRYSTAL LAKE TOWNSHIP FIREWORKS ORDINANCE:

In a nutshell, TOWNSHIP LAW provides that legal, consumer-grade fireworks are allowed ONLY on safe burn days and hours as follows:

- 11 a.m. on Dec. 31 to 1 a.m. on Jan. 1
- 11 a.m. to 11:45 p.m. on the Saturday and Sunday immediately preceding Memorial Day
- 11 a.m. to 11:45 p.m. on June 29 and 30, and July 1, 2, 3 and 4
- 11 a.m. to 11:45 p.m. on July 5, only if that date is a Friday or Saturday
- 11 a.m. to 11:45 p.m. on the Saturday and Sunday immediately preceding Labor Day

STATE OF MICHIGAN FIREWORKS LAW:

In a nutshell, State Law regulates fireworks -- ALL DAYS OF THE YEAR-- in the following ways:

- ONLY if consumer or low impact grade products;
- NEVER if on public property, including beaches, streets and sidewalks, at hospitals or schools, in playgrounds or parks.
- NEVER if a burn ban has been declared;
- NEVER if ignitor(s) are under the influence of alcohol or other intoxicating substances.
- NEVER if
 - A. deemed illegal or if not approved by the State of Michigan and/or by the State Fire Marshall, regardless of how it is labeled;
 - B. commercial grade without a state license;
 - C. homemade explosives.
