- Building Resilient Infrastructure and Communities
- Flood Mitigation Assistance

I also attached the acknowledgement letter from FEMA and a "status list" drafted from Mr. Frank Post in 2015 noting which communities approved the previous plan. **Whereas,** the 2023 Benzie County Natural Hazard Mitigation Plan 5 Year Update has been developed in accordance to the DMA of 2000 to reflect the concerns of the citizens and stakeholders of Benzie County; and

**Whereas,** Crystal Lake Township previously adopted the 2015 Benzie County Natural Hazard Mitigation Plan on Feb 10, 2015 by *Resolution No. 2.10.15-o5* 

**Whereas,** Crystal Lake Township affirmed participation in the maintenance of the 2023 Benzie County Natural Hazard Mitigation Plan and committed to participating in the update of the Plan no less than once every 5 years; and

**Whereas,** the 2023 Benzie County Natural Hazard Mitigation Plan provides a set of actions to reduce risk from natural hazards through education and outreach programs, establishes a foundation for coordination among agencies in Benzie County, identifies future mitigation projects, and meets the qualifications for federal assistance programs in order to be eligible for FEMA pre-disaster and post-disaster mitigation grant funding;
